KNOWN ALL MEN BY THESE PRESENTS:

Guizhou Industry Polytechnic College (GZGY), China, which is located at No. 49#, Songling Road, Guiyang City, the People's Republic of China, hereinafter referred to as GZGY, and represented in this Instrument by its Deputy Dean, Mrs. Wang Jin

and

SMK-SMTI PONTIANAK, having its domicile in Pontianak, Indonesia, which is located at Jl.Sulawesi Dalam No 31, Pontianak, West Kalimantan, Indonesia,
WITNESSETH

WHEREAS, GZGY is a Public college under directly the Education Department of Guizhou Province, People's Republic of China to offer undergraduate graduate academic college programs under the following four sub-colleges:

- Mechanical Engineering
- Chemical Engineering

WHEREAS, SMK-SMTI Pontianak provides diploma-level education and training in the areas of Mechanical engineering and Chemical engineering.

WHEREAS, GZGY and SMK-SMTI Pontianak have complementary objectives and a mutual desire to collaborate in a number of areas to pursue common educational and human development.

In consideration of the above premises and covenants hereunder provided, both parties to this Memorandum of Understanding (MOU) agree as follows:

1. To collaborate in undertaking programs, projects, and other related activities whenever and wherever feasible opportunities present themselves.
2. To exchange scientific materials, publications, and information.
3. To visit respective partner institutions
4. To exchange lecture/teacher
5. To exchange students
6. To collaborate in programs e.g. camp, workshop, training and seminar
7. To conduct online collaborative learning (joint degree, double degree, evaluation)
8. To execute separate agreements in writing for any particular undertaking jointly implemented, wherein sharing of responsibilities shall be specified and approved by both parties.

This Memorandum of Understanding takes effect upon signing by the authorized representatives of both Institutions, and remains in force for a period of 3 (three) years, subject to amendment at any time by mutual consent. The effect of the agreement will include all departments, offices and education and training institutes and centers under both parties. The said agreement shall be extended for an additional period of 3 (three) years at each expiration date, unless either party gives written notice to terminate the agreement at least six months prior to the expiration date.
